



### ACCOUNT ACCESS AUTHORIZATION FORM

Vision Communications (Vision) follows Customer Proprietary Network Information (CPNI) rules in accordance with the Federal Communications Commission (FCC) order to protect the privacy of information contained in your account. CPNI includes call detail information and certain account information, including the amount of your bill. These rules allow us to communicate account information only with the person(s) listed on the account. In addition, before we can answer questions or provide information related to the account, we must first be able to verify the person that we are communicating with is listed on the account. Requests can be accepted over the phone or by electronic mail or regular mail. The responses we provide will be determined by the authorization you provide below.

**In order for us to provide access to your account information to you and any person(s) you wish to authorize, please complete the applicable sections of this form and return this signed authorization form to our office so that we may update your account to provide the level of access you are requesting.**
